“3.6. Accordingly the following order is passed:-

The applicants shall be granted connectivity to Grid to operate their Grid Interactive Solar PV System upto sanctioned/contracted demand by installing a reverse power relay at their cost as specified by the Licensee so that the captive solar power so generated does not enter into the grid. Dedicated feeder is not required in such cases. Connectivity shall be permitted in the existing feeder to which the applicant's service connection is connected. The prosumers shall pay the applicable network charges to the Licensee for the entire generated units of solar power at the rate specified and in accordance with the orders issued by the Commission from time to time. The parallel operation charges shall not be applicable for such prosumers. The Prosumer shall install a solar generation meter at their cost. Interface meters shall be ABT compliant and as per the CEA (Installation and Operation of Meters) Regulations, 2006 and its amendments, with facility for AMR data transfer suitable to the protocol specified by the licensee. The petition is disposed of accordingly”.
