Thiru.Rahul Balaji, Advocate appeared for the petitioner. Thiru.Jai Singh, Advocate represented the Standing Counsel for TANGEDCO. The counsel for the petitioner submitted that the dues around Rs.57 crores has not been paid till now despite the order of the Commission in its daily order dated 19.03.2024 and prayed to direct the TANGEDCO to release the payment immediately. The official of TANGEDCO submitted that the TANGEDCO is ready to make payments in 48 instalments and 1st instalment would commence on 5th April, 2024. Commission expressed its displeasure on the conduct of TANGEDCO in not complying with the orders of the Commission in payment related cases and directed Director (Finance) to appear in person before the Commission on 02.04.2024 and to explain why the orders passed by the Commission are not being complied with. By then, the payment of Rs.57 crores shall be made by TANGEDCO and a compliance report thereon shall be submitted. The case is adjourned to 02.04.2024 for verification of compliance.
