3. The tender will be opened on the **same date i.e on** on **31-01-2024** at **03.00 PM**. in the presence of such of those tenderers who are present at the time of opening the tender.
4. If the due date of tender opening is declared as a holiday the tender will be opened on the next working day at 03.00 PM.
5. The above items can be inspected in the office of the Commission from 10.30 am to 5.00 pm on all working days and till 12.00 noon on the last date.
6. The rates quoted should be both in figures as well as in words.
7. The undersigned reserve the right to split the tender, accept any tender or cancel the tender without assigning any reason.
8. Specific concurrence or otherwise to all the terms noted herein should be furnished in the tender. Failure to do so will be taken as concurrence to the terms.
9. The tender will be confirmed in favour of the highest bidder. The bid amount should be remitted within 3 days from the date of confirmation of auction sale.
10. If the highest bidder fails to pay the bid amount within three days, the tender will be allotted to the next highest bidder.
11. The auctioned items should be taken out from the office of the Commission within four days of payment of bid amount, failing which, ground rent @ Rs.100/- per day will be charged. If the items are not taken out within ten days of the payment of bid amount, the bid amount will be forfeited.
