

## TAMIL NADU ELECTRICITY REGULATORY COMMISSION

Tamil Nadu Electricity Regulatory Commission (TNERC) is a statutory body constituted by the Government of Tamil Nadu in accordance with the Electricity Act, 2003 and is located at Chennai. It is vested with powers to determine the electricity tariff and to regulate power purchase and procurement process, issuing licences and adjudicate upon disputes. The Commission is looking for a suitable candidate to fill up the post of **Director (Tariff)** by deputation/direct recruitment/contract basis. The above post carries allowance and other facilities as applicable to the employees of the Government of Tamil Nadu.

Those who are working in Government / Public Sector Undertakings / Corporations / Boards / State electricity utilities and desire to come on deputation may also apply, in which case they will be covered under foreign service terms and conditions of deputation of the Government of Tamil Nadu. Such candidates should apply through proper channel with a "No Objection Certificate" from their employer or should produce the same at the time of interview.

Mere fulfilling of eligibility criteria shall not bestow any right to be called for interview. Only short-listed candidates shall be called for an interview. TNERC reserves the right to keep this post unfilled depending upon the circumstances prevailing at the time of selection. The Commission shall have full discretion to fill up the post either by direct recruit or deputation or through contract basis. The Commission's decision in this regard shall be final.
