## Amendments to Fees and Fines Regulations, 2004

(Notification No. TNERC/Regulations/F&amp;F/4/2-9 dated 12-2-2018)

No. VI(2)/27/2018.

In exercise of the powers conferred by clause (g) of sub-section (1) of Section 86 read with Section 181 of the Electricity Act, 2003 (Central Act 36 of 2003) and all other powers enabling it in this behalf, the Tamil Nadu Electricity Regulatory Commission hereby makes the following amendments to the Tamil Nadu Electricity Regulatory Commission – Fees and Fines Regulations, 2004, the draft of the same having been previously published as required by sub-section (3) of Section 181 of the said Act.

## AMENDMENTS

In the said Regulations, in regulation 6, in the Table,-

- (1) after item No. 2 and the entries relating thereto, the following items and entries shall be inserted, namely:-

"2A Approval for fees and charges collectable by SLDC from the generating companies and licensees engaged in Intra-State Transmission of electricity under Section 32(3) of the Electricity Act, 2003.	0.02% of the revenue receipt in the preceding year";

## EXPLANATORY STATEMENT

Consequent to the separation of the functions of State Load Despatch Centre from the Transmission Licensee in the State of Tamil Nadu, the State Load Despatch Centre (SLDC) has started filing petitions on its own for approval of levy and collection of fees and charges from the Generating Companies and Licensees engaged in Intra-State Transmission of Electricity for meeting its operational needs. In view of the same, it has been decided by the Commission to collect fees from the SLDC in respect of such application/petition to be filed before the Commission by the State Load Despatch Centre (SLDC) from time to time as is being done by the Transmission and Distribution Licensees.

This amendment seeks to give effect to the above decision.
