M.P.No.28 of 2011 and I.A. No. 1 of 2011 came up for final hearing  
before the Commission on **3-11-2011**. The Commission upon perusing the above

petition and the connected records and after hearing Thiru.E.Manoharan, Advocate for the Petitioner passed the following:-

**ORDER**

**1. Prayer in M.P. No. 28 of 2011**

The prayer in M.P. No. 28 of 2011 is

- (ii) to direct the Respondent to execute PPA in favour of the Petitioner for the months of June, July, August and September 2011, at the rates stipulated in the order of the Hon'ble Commission dated 11-7-2011.
- (ii) to direct the Respondent to effect payment to the Petitioner accordingly for the power generated at their plant and supplied to the first Respondent, after meeting the requirement of the captive consumers, from 1<sup>st</sup> June 2011.

**2. Prayer in I.A. No. 1 of 2011 in M.P. No. 28 of 2011**

The prayer in I.A. No. 1 of 2011 in M.P. No. 28 of 2011 is to treat this petition as urgent and accordingly list the same for hearing and may pass necessary relief as sought for by the Petitioner.

**3. Hearing on 13-9-2011**

Thiru R.Muthukumarasamy, Senior Advocate appeared for the Counsel on record for the Petitioner. The petition is filed with a prayer to direct the Respondent to execute PPA in favour of the Petitioner for the months of June, July, August and September 2011 and direct to effect payment for power supplied. After hearing, the Commission admitted the petition and ordered notice

to the TANGEDCO. TANGEDCO has to file counter within 4 weeks on the proposal of the Petitioner.

4. **Memo filed by the Petitioner**

The Petitioner in their Memo filed has interalia stated as follows:-

*"It is submitted that the Hon'ble Commission was pleased to hear the matter and directed the Respondent to file counter in the said matter. While the matter lay thus, the Hon'ble Commission had passed order in I.A. No. 1 of 2011 (P.P.A.P. No. 5) fixing the rate for purchase of power by TANGEDCO till May 2012 and subsequently TANGEDCO entered into Power Purchase Agreement with Sai Regency Power Corporation Private Limited, the Petitioner herein".*

5. **Hearing on 3-11-2011**

Thiru.E.Manoharan, the Counsel on record for the Petitioner submitted that he is filing a Memo praying the Commission to close the M.P. No. 28 of 2011 since further hearing of the petition is not necessary. M.P. No. 28 of 2011 and I.A. No. 1 of 2011 are closed as prayed for.
