Thiru.R.Muthukumarasamy, Senior Counsel appeared for M/s.Gupta and Ravi, the Counsel on record for the Petitioner. The above Miscellaneous Petition

along with interim application are filed praying to direct the Respondents to extend the benefits of T.O. No.1 of 77 dated 20-3-2006 to the Petitioner also as in the case of similar consumer Nethaji Apparel Park, Palladam Hi-Tech Weaving Park and Tirupur Knitwear Industrial Park as per Commission's order dated 4-5-2010 and consequently set aside the proceedings of the Second Respondent in the communication bearing Ref. No.SEM/AEEGL/AE/F.HT SC No.278/PR No.170/11, dated 10-2-2011. The Second Respondent has issued a notice dated 10-2-2011 stating that since Commission has withdrawn single point HT supply to weaving parks, the HT SC No. 278 cannot be permitted to continue and therefore to be surrendered. It was further stated in the notice that 28 numbers of application submitted by the individual entrepreneurs requesting LT supply for their sheds (units) have been registered and action is being taken for effecting supply and that at the time of effecting L T supply the HT supply will be withdrawn. The interim prayer is sought for restraining the Second Respondent from disconnecting the HT connection S.C. No. 278 of the Petitioner. The Counsel for Tamil Nadu Electricity Board who was present has submitted that the impugned communication is pursuant to the interim orders of the High Court in a pending Writ Petition filed by 19 consumers in the premises of the Petitioner. After hearing the matter, the petition is admitted and the following interim order is passed:-

INTERIM ORDER

The Tamil Nadu Electricity Board has served a notice on 10-2-2011 to M/s.Cauvery Hi-Tech Weaving Park threatening to disconnect the single point HT supply. This order is stayed till the disposal of the main petition. As regards the

19 applicants for LT connection covered by the High Court order, the Tamil Nadu Electricity Board may abide by the order of the High Court. The Tamil Nadu Electricity Board may also bring out in their counter whether there are similar single point LT connections elsewhere in the State.
