In the matter of non-compliance of the orders of the Commission dated 28-11-2008 issued in M.P. No.42 of 2008 - Issue of Notice to TNEB

ORDER DATED 16TH DECEMBER 2008

The petition from 55 complainants given in the Annexure for non-compliance by the TNEB of the orders of the Commission dated 28-11-2008 in M.P. No.42 of 2008 was taken up under Section 142 of the Electricity Act 2003.

The TNEB explained that excepting the enhancement of demand and energy quota for windmill captive consumers, the Order has been implemented.

As on the date,` the Order of the Commission has not been stayed by the competent authority under the law and therefore we observe that TNEB is bound to give effect to the order in full particularly because the non-enforcement of the clause on enhanced demand and energy quota for windmill captive users would result in irreparable loss and would amount to frustrating the orders of the Commission irreversibly.

This loss cannot be made good, especially the one relating to the enhancement of demand quota. We observe that the balance of convenience for the TNEB and the consumers lies in enforcement of the entire order and inserting a clause in the enforcement order to the effect that any excess charges resulting from review / appeal will be realized from the consumers. We find that a similar clause already exists in the enforcement order issued by TNEB.

As regards the irretrievable loss caused to the consumers due to the non-implementation of the order from 28-11-2008 till the date of implementation, the Commission would pass appropriate orders separately.
